GERMANY, AND WAS OBSERVED IN THE NEAFC REGULATORY AREA TRANSHIPPING
FROZEN FISH

FROM NON-CONTRACTING PARTY FISHINGS VESSELS.

ACCORDING TO THE TERMS OF BALTIME 1939 UNIFORM TIME-CHARTER DD APRIL
22ND,

2005 "THE VESSEL TO BE EMPLOYED IN LAWFUL TRADES FOR THE CARRIAGE OF
LAWFUL MERCHANDISE...". UNDER THE TERMS OF THIS CHARTER-PARTY
THE VESSEL WAS OBLIGED TO FOLLOW THE DIRECTIONS OF THE TIME-CHARTERES
'PIRO-FISCH GMBH' TO MASTER (WHERE TO PROCEED, WHAT CARGO AND FROM
WHAT FISHING VESSEL TO LOAD, ETC.).

AFTER INVESTIGATIONS UNDERTAKEN BY NEAFC AND IMMARBE, OWNERS/OPERATORS
FULFILLED ALL REQUIREMENTS AND THE VESSEL WAS RELEASED UNDER
'PROHIBITION OF SAILING'.

PLEASE ADVISE IF THE VESSEL CAN BE DELETED FROM IUU A-LIST.

PLEASE ADVISE IF WE CAN WORK IN THE NEAFC REGULATORY AREA
TRANSHIPPING CARGO FROM CONTRACTING PARTY FISHINGS VESSELS
ACCORDING TO NEAFC RULES.
